Attached is a revised WVSA Referee Program Policy Manual as approved by the WVSA Referee Committee. Please review the explanation from Mike McCarthy that reviews the reasons for the changes.

Attached is a proposed, revised version of the WV State Referee Program Policy Manual for consideration by the WVSA Board.

This version comes recommended by the State Referee Committee on a vote of 8 - 0 with one voting member not casting a vote to date.

Summary of changes:

- The only substantive change is the creation of the position of State Director of Referee Development (SDD), a combination of the historic positions of State Director of Instruction (SDI) and State Director of Assessment (SDA).
 - This change aligns with the spirit of U.S. Soccer's own efforts in recent years to combine the roles of instructor and assessor into mentor or referee coach.
 - This change also aligns with recent changes in other state SRCs in the creation of a single position responsible for the "development" (training, evaluation and coaching) of referees, such as the Massachusetts SRC with its naming of Kara Honthumb to the role of SDD.
 - These revisions stipulate that the incumbent in the position of State Director of Development fulfills the roles of both SDI and SDA as currently required by U.S. Soccer policy, but that the incumbent casts only a single vote on the State Referee Committee.
 - The term of the SDD is stipulated to align with the previous position of SDA -- namely, a two-year term starting on January 1 of even-numbered years.
- Other changes reflect alignment with current verbiage and licenses used by U.S. Soccer; for example, the use of the terms "mentor" and "coach" in place of the deprecated terms of "instructor" and "assessor."

- Highlighted areas denote additional changes that the State Referee Committee has not yet formally adopted but which it and the WVSA Board may wish to consider in the near future, including:
 - An adjustment to the number of Referee-at-Large seats on the SRC so that, in light of the combination of the SDI and SDA positions into the single position of SDD, the overall number of voting members of the SRC remains an odd number (Policy 201 Sec 2.5).
 - Change in the Risk Management process for Referees given the use of the NCSI Background Checks in the Learning Center for all U.S. Soccer Referee Program licenses (Procedure 202.1.5). Note that allowance may still need to be made for the Youth Coach and Adult Player members of the SRC, should those positions be maintained, since they may not be subject to the NCSI Background Check process.
- Also below is the recommendation of Mike McCarthy that Doug Sharpe be appointed WVSA SRA, effective 1/1/2024. WVSA President Len Rogers asks for approval of this appointment Please email your approval or disapproval of this appointment to <u>dave@wvsoccer.net</u> by 5PM 12/11.
