SELECTION PROCESS FOR NOMINATIONS:

1. Deadline for submission of this year's nominations: **received by November 1, 2025.**
Nominations may be received by mail, delivery service, or email.
2. Hall of Fame Inductees will be presented and honored at the West Virginia Hall Of Fame Dinner at a TBD date and location.

GENERAL CRITERIA:

1. Nominations for persons to be inducted into the West Virginia Soccer Association Hall of Fame may be submitted by any person who has been or is a player, coach, referee, or administrator for West Virginia Soccer Association, West Virginia Youth Soccer Association or West Virginia Adult Soccer Association. All resumes shall be typed on the Resume form attached to this West Virginia Soccer Association Hall of Fame Nomination Form.
2. The recognition must be for significant personal achievement in, or contribution to West Virginia Soccer Association, West Virginia Youth Soccer Association or West Virginia Adult Soccer Association. In addition, the demonstrated, positive effect of such achievement or contribution must have set a clear and recognized example for the soccer community to emulate and regard as a model to be followed for personal achievement.
3. Players - must have reached the minimum age of 25 and have distinguished themselves with an outstanding standard of play and/or performance as a member of West Virginia Soccer Association, West Virginia Youth Soccer Association or West Virginia Adult Soccer Association. The player must have participated in games as a registered member of West Virginia Soccer Association, West Virginia Youth Soccer Association or West Virginia Adult Soccer Association for at least 6 consecutive years.
4. Administrators, Referees, Coaches, etc. - must have demonstrated outstanding accomplishments and/or leadership that have made significant contributions to the improvement of the sport and its participants nationwide. They must have contributed directly for a period of 6 or more years for West Virginia Soccer Association, West Virginia Youth Soccer Association or West Virginia Adult Soccer Association.
5. Meritorious Recognition - Nominations for this Recognition are for individuals or organizations involved in the support of West Virginia Soccer Association, West Virginia Youth Soccer Association or West Virginia Adult Soccer Association in non-playing, non-administrative, non coaching, and non-refereeing capacities.

Completed nomination forms shall be sent to the West Virginia Soccer Association and must be received no later than November 1, 2025.
